# Your journey starts here



## Admissions process

All elements of your application will be thoroughly reviewed by the Admissions Team. The selection process is on a rolling basis that will take up to eight weeks from the date of completed application submission.



## Admissions criteria

The MIM Admissions Team is looking for candidates with intellectual curiosity, personal qualities to contribute to the many INSEAD activities and very strong international motivation.

### Ability to contribute

The capacity to bring something distinctive and meaningful to the MIM experience, both during and after the programme.

### Academic performance

A sound academic foundation and a GMAT/ GRE score are required, along with an undergraduate degree (bachelor's degree or equivalent).

### International motivation

Adaptability and flexibility in multicultural environments are essential.

### Work experience

Full-time professional experience is not required, although some exposure to a business context is valued.

## Application rounds

Your application will be evaluated as soon as it is complete, including your two recommendation letters, irrespective of when you apply. Final decisions are released at any point of time within eight weeks of you submitting a complete application.
