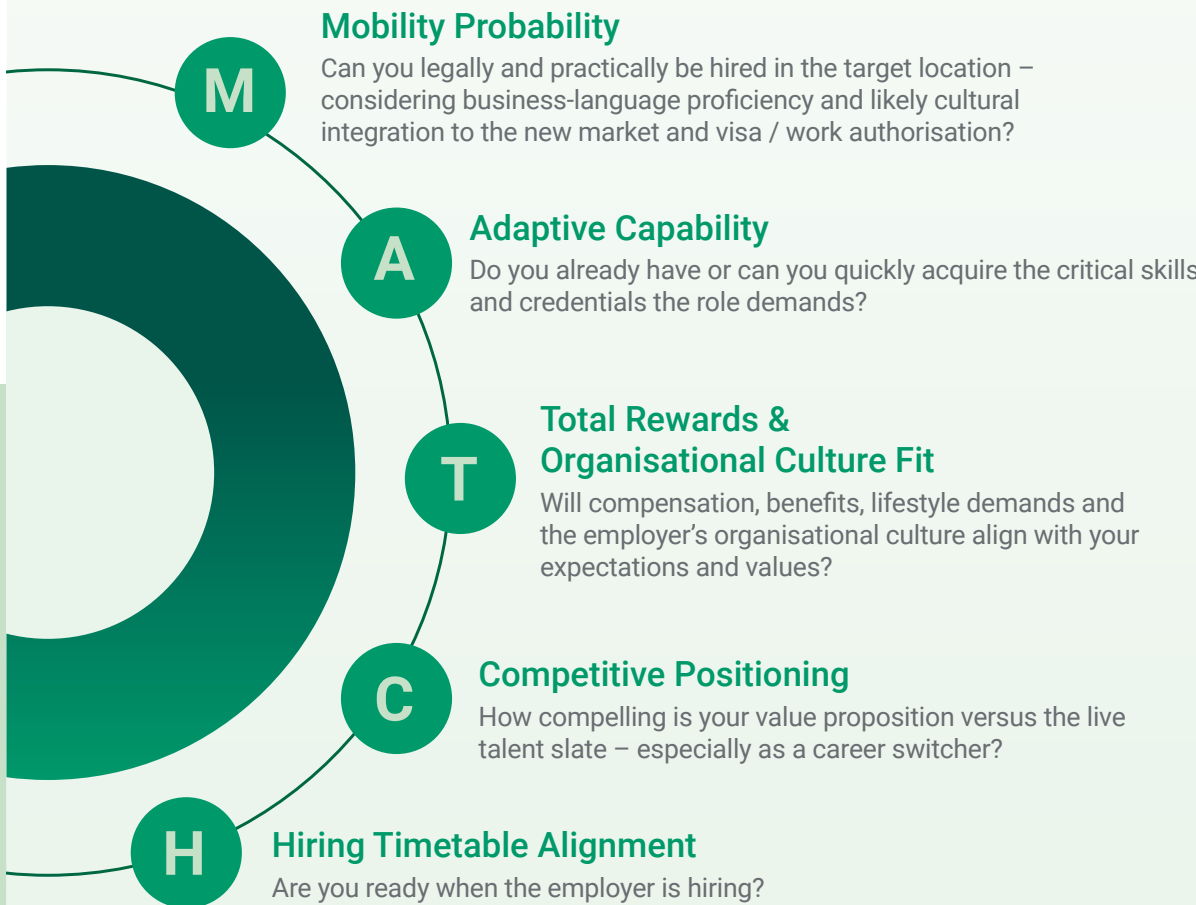
# MATCH Framework

Your assigned coach holds the full picture of your situation, backed by career professionals across four continents and deep employer relationships across sectors and geographies.

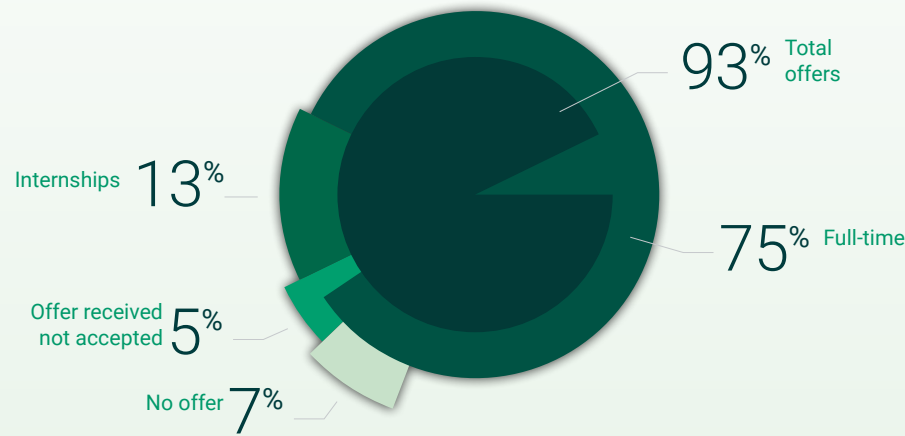

# Your journey starts here

## Admissions process

All elements of your application will be thoroughly reviewed by the Admissions Team. The selection process is on a rolling basis that will take up to eight weeks from the date you submit your application.



## Admissions criteria

We seek bright, motivated individuals with a solid academic foundation, a global outlook and the ability to thrive in a dynamic, multicultural community.

### Academic performance

An undergraduate degree or equivalent, along with a strong academic foundation and a GMAT or GRE score.

### International motivation

Adaptability and flexibility in multicultural environments are essential.

### Ability to contribute

The capacity to bring something distinctive and meaningful to the Master in Management experience, both during and after the programme.

### Work experience

Full-time professional experience is not required, although, some exposure to business contexts is valued.

## Rolling admissions

Your application will be evaluated as soon as it is complete, including your two recommendation letters, irrespective of when you apply. Final decisions are released at any point of time within eight weeks of you submitting a complete application.
